### Task number 1:

Pursuant to the content of Chapter XII point 10 of the TERMS AND CONDITIONS OF THE CONTRACT, the Contracting Authority shall cancel the procedure, because no tender has been submitted in the procedure which cannot be rejected.

At the same time, we would like to inform you that the following offers have been rejected:

1) Laboratory Instrumentation Limited, Unit 7, Farrington Industrial Center Farrington, Alton, Hants., UK GU34 3DD pursuant to Chapter III point 16.1) TERMS AND CONDITIONS OF THE CONTRACT - the content of the offer does not correspond to the content of the TERMS AND CONDITIONS OF THE CONTRACT. In accordance with the content of Chapter VI point 1.5) of the TERMS AND CONDITIONS OF THE CONTRACT, as confirmation of the fulfillment of the condition for participation in the procedure set out in Chapter V. point 1.5) - Disposing professional experience understood as the completion of at least 2 deliveries of nebulizers or devices for in vivo testing in the last 3 years before the deadline for submitting offers, with a minimum value of PLN 400,000.00 each, the Contracting Authority required

the submission, along with the offer, of a List of supplies to the extent necessary to demonstrate compliance with the condition of knowledge and experience, performed in the last three years before the deadline for submitting offers in the procedure, stating their type and value, date and place of performance, and attaching a document confirming that deliveries have been performed properly. The Contractor has submitted a List of Deliveries, but has not submitted documents confirming the proper performance of the deliveries. The Contracting Authority, in a letter of 30/05/2022, called the Contractor to supplement the documents. In response, the Contractor sent the procurement documents, invoices, etc. documents. On their basis, the Contracting Authority is not able to recognize the condition set out in TERMS AND CONDITIONS OF THE CONTRACT as fulfilled. Moreover, the documents have not been certified as true copies or signed (in accordance with Chapter VI point 4 of the TERMS AND CONDITIONS OF THE CONTRACT). In addition, the Contracting Authority, in a letter of 1 July 2022, called the Contractor to supplement the Power of Attorney to submit the offer granted to Mr. Antonio Albear. The contractor did not complete the documents within the prescribed period.
